Processing of personal data

We only process personal data to the extent necessary to fulfil our tasks. We process the following personal data:- e-mailadres,

- first name,
- middle name,
- last name,
- address details,
- customer number,
- order history,
- bank details,
- technical data such as your IP address, MAC (Media Access Control) address, identifiers in cookies and data about your activities on our website.

We only use personal data for the following purposes:

- to maintain contact with you,
- to execute the agreement with you,
- to comply with our administrative obligations,
- to combat fraud.

Special and/or sensitive personal data

We only process personal data of persons under the age of 16 if we have permission to do so from the person with parental authority. By offering us personal data for processing, you declare that you are at least 16 years old or that you have permission for the processing from your parents or other persons with parental authority. If we determine that a person in our file is under the age of 16 and has not been given permission for the processing by a person with parental authority, we will delete the personal data.



If you have any indications that we are processing personal data of a person under the age of 16 without the permission of the authorized person, please contact us at online@saskiasnijders.com so that we can delete the data in question.

Retention of personal information

In order to limit the risk of loss of personal data as much as possible, we only store personal data for one year. We do this for your convenience. By storing your personal data for one year, it is not necessary for you to provide us with your personal data each time. If you agree to our privacy policy again within the year in which we store your personal data, we can store your data for another year from that moment on. We can only store your personal data for longer in order to meet our legal obligations.

Security of personal data

We value your personal data and have therefore taken the following measures to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification.

- The connection to the website (<u>www.saskiasnijders.com</u>) is established via a secure connection.
- The computers on which the personal data are processed and stored are always provided with the latest security updates from Windows or Apple.
- The computers on which the personal data are processed and stored are equipped with an adequate virus scanner.
- A processing agreement has been concluded with all external parties who have access to personal data, on the basis of which these third parties have undertaken to maintain confidentiality and to process the personal data only on behalf of Saskia Snijders Coach for Moms.

Sharing personal data with third parties

We do not sell personal data to third parties and only provide it to others if this is necessary for the execution of our agreement with you or to comply with a legal obligation. Cookies on www.saskiasnijders.com

In order to make our website function optimally, we use third-party services, but we also think about your privacy. The cookies on our website do not endanger your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit



our website. The cookies ensure that the website functions properly and that your preferences are saved. We, and any third parties we may engage, do not process your IP address in a way that can be traced back to you. Cookies can be deleted via your browser settings. It is also possible to set your browser so that cookies are no longer stored.

Rights of persons whose personal data we process

Your data remains yours. You always have the option to view which data we process about you, to have the data corrected or deleted. In addition, you can withdraw your consent for the data processing or object to the processing of your data by us. If you wish, we will send your data in a computer file to you or to an organization designated by you.

You can send a request for access, correction, deletion, transfer of personal data, withdrawal of consent or objection to the processing of the data to <u>online@saskiasnijders.com</u>.

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. In this copy, black out the passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) so that this data cannot be intercepted by third parties. We will respond to a request within four weeks.

Other

Automated decision-making

We do not use personal data for automated decisions. This is of course self-evident, but we are obliged to mention it.
